## NMAA Application for Bylaws Adoption/Revisions Services

If you are interested in updating your acequia's bylaws, you have come to the right place! Over the years, NMAA has assisted hundreds of acequias all over New Mexico in reviewing, updating and adopting acequia bylaws, the governing document of an acequia. NMAA has experienced staff that can assist your acequia through every step of the revision and adoption process. In order to get the ball rolling, please review the following information:

- In order for your application to be considered, all meetings must be scheduled prior to June 1, 2018. All adopted bylaws must be signed and submitted to NMAA prior to June 15, 2018.
- NMAA requires proof of proper notice of bylaws adoption meetings. Upon request,
   NMAA may assist with providing proper notice to members and the public of the bylaws adoption meeting.
- In order to provide the best possible outcome, an acequia requesting assistance should locate a copy of the acequia's current bylaws and provide a copy to NMAA. Bylaws may be found in the records of the acequia or in the records of the State Engineer, Interstate Stream Commission, or County Clerk. If your acequia is chosen, your acequia will be required to sign a Memorandum of Understanding (MOU) listing the specific bylaws related services NMAA will provide and the responsibilities of the acequia and/or its designee during the bylaws revision process.
- Due to NMAA's limited resources, it may, at its discretion, limit the amount of time it
  invests in the project free of charge. Therefore, the more involved and active the
  acequia or its designee is during the bylaws revision process, the less likely it will be that
  NMAA has to charge for its services. A fee schedule may be attached to the MOU.

10) What is your current requirement for adopting or revising bylaws?
11) What is your current voting method?
12) Do you have a membership list? If so, when was it last updated?
13) What do you perceive are potential challenges to adopting or revising bylaws?
